Eligibility:

- Officials who were appointed at the entry level post of Technician / T-1 (Cat.I) & Technical Assistant / T-3 (Cat.II) at any ICAR Institute and Senior Technical Assistant / T-4 (Cat.II) at any ICAR-KVK.
- The employee should have completed five years of service after their initial appointment on the date of notification of calling of applications, except in case where request is on medical/ working spouse ground necessary certificate should be enclosed as per Council's letter dated 19.03.2020.
